ASB/Crime/Criminal Damage

- We received a report of a cat scarer causing a noise nuisance for residents in the Forge Way area. Residents were advised regarding the HDC policy on noise complaints and we will monitor the area for any noise nuisance going forwards.
- We received reports of loud music in the Lower Station Road recreation ground area. We attended and a resident was spoken to and advised about the music, which was then turned off.
- We spoke with a resident who reported noise related ASB and will increase patrols in that area as a result. The local Police Community Support Officer will also be informed.

Parking/Vehicles

- We submitted two Intelligence forms to Sussex Police regarding ice cream van's driving in and around the village acting suspiciously.
- We supported a resident in the village after continuous reports of ASB relating to a neighbour's vehicle. The local PCSO and Police were informed, and the vehicle was removed by the neighbour.
- We reported the driver of an ice cream van to Operation Crackdown for using his mobile phone whilst driving in the village.
- We reported a driver of a car to Operation Crackdown and DVLA for speeding in the village and for having no tax.
- We noticed a business had parked two vehicles in the High Street. The business owner was called and the vehicles were removed after speaking to the drivers.

Fly Tipping/Littering/Graffiti

- We carried out a litter pick in Station Road Gardens.
- We carried out a litter pick in Daux Wood area after reports of litter being dumped in the area.
- We carried out a litter pick of Honeysuckle Drive and arranged collection of larger items by Horsham District Council.
- Graffiti in Natts Lane reported to Horsham District Council for removal.
- Drugs litter found in Station Road Gardens and removed.

Community Engagement/Events/Meetings

Due to the restrictions in place due to Covid-19 we have been unable to complete in any face to face community engagements. We are looking at arranging 'pop up' street briefings in the near future.
