An incident reported on Facebook regarding 4 young males approx. trying to set a fire in Forge Way area; police informed and school informed regarding this. Area patrolled for reassurance and to see what damaged has been caused.

Multiple reports being sent to local police and other agencies around males in the Tesco/ Station Road area who are believed to be involved in illegal activity.
