## ASB/Crime/Criminal Damage

We had reports of ASB in Rowan Drive area, site is being monitored with information being passed to housing officers and the police where required.

We have reported green areas of concern to the local police force who have been carrying out evening patrols in these areas. (Including green space at the top of the church path)

We gave advice and visited a resident after complaints of noise from a residential area in the south of Billingshurst.

## Parking/Vehicles

We verbally warned a driver ref. parking on the pavement in a residential area.

We reported 2 vehicles for no tax to DVLA and Operation Crackdown after they were seen parked in residential areas around the village

We submitted 2 Intelligence forms to Sussex Police ref Ice cream vans driving in and around the village acting suspiciously.

We issued a yellow parking warning to a car parked obstructing a pavement.

We advised a resident ref use of electronically-propelled vehicles and their use.

We submitted an Intelligence form to Sussex Police ref a suspicious vehicle in the village.

## Fly Tipping/Littering/Graffiti

We reported Fly Tip (Small Commercial) in West Chiltington area to Horsham District Council for removal.

We moved dumped items (including a bike) away from Lower Station Road skate ramp and reported it to be cleared away.

We carried out a litter pick in Lower Station Road Skate Park.

We carried out litter picks in the green area by the big tree at the bottom of Daux Road.

We requested a large amount of broken pallets to be removed via the local landowner that were going to be used as a bonfire from a green area by Daux Road. (Removed)

We removed drug litter from an area near Daux Woods and then made reports to WSCC / Police

We advised the relevant persons including police of ongoing damage being made to the vegetation in Daux Wood.

## Patrols (foot/visible and car)

We carried out Parish wide and Fly Tip patrols.

We continue to regularly patrol the Rowan Road area after reports of low level ASB by several residents. We also informed the relevant Housing Association to monitor.

We continue to regularly patrol the green spaces around the village after reports of various levels of ASB occurring.

## Elderly and Youth

We have completed regular weekly welfare checks on vulnerable members of the community.

We have continued to carry out weekly friendly doorstep chats for members of the community struggling with social isolation.

We have collected face masks made from the support group and distributed to local residents.

We referred a vulnerable resident and delivered free complimentary meals courtesy of the Billingshurst Community Partnership and Little Bean Café.

We have made a safeguarding referral regarding concern the safety of a vulnerable person.

We have contacted an elderly member of the community's GP regarding concerns about that person's mental health.
