Dear Sir,

I have been approached by Mr Eric Bonner, the Coordinator of the Billingshurst Speed Watch Group to establish the possibility of acquiring a new speed radar gun at a cost of £1,684.95.

The desired modal is a Scout 2 speed indication device marketed by Decatur UK. http://www.decaturelectronics.co.uk/products.html

The advantage of this equipment is that it has enhanced features which eradicates false speed readings when there is traffic moving in opposite directions. It is a recommended advice by Mr Steve O'Connell who is the Sussex Police lead for the county speed watch programme.

Arguably the current speed monitoring device has served us well enough, particularly having regard to the fact that the device is not used as evidential evidence of speed in court cases. Our monitoring of speed simply results in a motorist receiving a letter requesting their cooperation in observing speed limits in the future.

FOR DECISION

At the last meeting, Members received a report indicating that Council assets were over insured for replacement purposes, inviting members to consider whether the level of insurance should be retained or reduced accordingly.

The Committee agreed to *DEFER* consideration of possibly reducing insurance cover until the insurer gives an indication of how much could be saved on future premiums. (Min 25/23 refers).

I asked the insurer accordingly, and he then asked by how much we wished to reduce the cover for each asset! My suggestions are as set out in the last column of the table below.

I can now confirm that to reduce the building sums (as per the column marked "My suggestion" below) insured WEF 27/02/23 until renewal on 15^{th} Nov 2023 would create a pro rata refund of ± 106.03 . This is roughly an annual saving of ± 987.40 .

FOR DECISION

On 1 March 2023, Council supported a draft program of events on the weekend of the Coronation in May.

An application to the National Lottery Community Fund for £7,500 has unfortunately been declined. Their response is as follows:

We cannot take your application any further. We'd like to help you understand why. We have received a large number of applications and cannot fund them all within our available budget. Such is the demand for our funding, that we are unable to fund your project as it does not address our funding priorities as strongly as other applications. While we understand the benefits of your plans, other applications have more strongly demonstrated community involvement in the design, development and delivery of the proposal, and how the project would build strong relationships in and across the community. We recognise that this will be disappointing to you and your community and hope that you are able to make arrangements for your project to go ahead. You are welcome to make a new application at any time. Please note that if you would like to make a new application for activities taking place over the Coronation weekend it must be received no later than 24 March. We know it takes a lot of effort to put an application together. We appreciate you taking the time to apply.

Unfortunately there was not time to review and resubmit the bid by 24 March.

For the Platinum Jubilee last year, the Council had no specific budget for the events it supported and merely relied on overspends elsewhere; this was not ideal.

Members will be aware that the Council has recently received £420,126.92 by way of a commuted sum to support the transfer of Public Open Space (POS). This has been placed in a high interest Treasury Reserve Deposit for 6 months and will generate £7,066.05 interest.

The Committee is invited to consider allocating no more than this £7,066.05 windfall to the forthcoming Coronation weekend.
