Carers feel supported, reassured and better able to cope with the demands of caring for their loved ones. Visits are made to patients at home to monitor and review their medication, care for wounds and provide advice on managing pain and other symptoms Therapies and Wellbeing services are provided to help people have as good a quality of life as possible in the precious time they have remaining. Bereavement support is available to those grieving the death of their loved one. "The best thing was getting reliable, expert advice when we needed it. When people said they would call back, they did. When we were offered help, we got it. We felt like we were in
		safe hands and able to manage at home."

Supporting information for Billingshurst Parish Council



Facing our greatest funding challenge

At St Catherine's Hospice we face the most significant funding challenge in our history. Whilst inflation has soared more than 24% in the last 10 years, our statutory funding support has only increased by 3%, despite continuously rising care and service delivery costs. This has heightened the pressure on our expenditure budget, and in April, it will be further exacerbated by the increase in our National Insurance wages bill. Additionally, a growing and ageing population demands more complex palliative and end-of-life care, and the need for our specialist hospice services will continue to rise.

Our expert teams continue to deliver vital care and support to local people facing the hardest of times. Now, more than ever, we need your help.

"Every single person at St Catherine's, from the doctors, the nursing staff, receptionists and community team were just brilliant. The care and compassion you all gave to me showed no bounds. Whenever I walked into St Catherine's it was like receiving the biggest hug on earth."

About St Catherine's

St Catherine's was incorporated 45 years ago and is proud to be rated 'Outstanding' by the Care Quality Commission for the care we provide to adults on our wards and in the community across West Sussex and East Surrey. Our services are free for those referred by local GPs and healthcare providers within our community. Alongside clinical, therapeutic, and personal care, we offer spiritual guidance, welfare advice, social work, and bereavement support. We also have a telephone advice line that provides expert medical guidance and emotional support to patients, their carers, and our local health and social care colleagues. St Catherine's is honoured to have the support of over 940 dedicated volunteers who contribute to our charitable work.

We also work closely with the local NHS, sharing our expertise to inform future care delivery and provide specialist training and education to local health and social care colleagues, pioneering standards in palliative care. Additionally, we collaborate with hospices across Sussex and Surrey to share learnings and best practices.

Caring for our community

Last year, the age of our patients ranged from 18 to 103. Whilst the majority of patients (64%) have cancer as their primary diagnosis, we also care for people affected by conditions including motor neurone disease, heart disease, chronic pulmonary conditions and dementia.

Our expert teams specialise in different types of palliative care and help people manage symptoms such as pain, nausea, and shortness of breath, and offer emotional support that might include counselling or time with our spiritual care team who are there for people of all faiths and none. Eight in ten people choose to be cared for in their own home. Patients who are well enough to travel, can visit our new hospice for outpatient appointments with our specialist clinicians, one-to-one gymbased exercise sessions and group classes, supporting them to live well and remain as independent as possible.

For those staying on our hospice wards, alongside 24-hour specialist medical and clinical care, St Catherine's strives to create precious moments that make all the difference to people at the end of life. For example, sipping a favourite drink with a loved one in our beautiful gardens, enjoying a freshly cooked meal, a visit from their pet dog, a spa bath, or listening to beautiful melodies performed by our volunteer musicians. For people grieving the death of their loved one we offer bereavement support, such as STEPS an informal 'walk and talk' group and Time to Remember services where they can find comfort and solace with others, listen to meaningful readings, and light a candle in remembrance.

Measuring Success

In addition to our 'outstanding' CQC rating, we receive positive feedback from patients, families and carers on the difference our hospice care services make, and 86% of those asked said they would recommend St Catherine's. We are also proud to be accredited by Continuing Healthcare Knowledge Systems, recognising our commitment to the highest levels of quality and improvement. First accredited in 2017, we were recently reaccredited in January 2025.

Funding position

We receive less than a third of our income from the NHS and rely on the continuing generosity of our supporters and the local community to raise around £7.5 million each year to fund our vital end of life care services. We continue to regularly and robustly review our financial position and recently undertook a cost-saving exercise to ensure the long-term sustainability of our charity.

With your support, local people facing the end of life will be able to spend their final days as pain free, dignified, and comfortable as possible while their families feel supported, reassured, and have the resources they need to care for their loved one.

"You allowed my husband to die with dignity and more importantly with me holding his hand. Allowing me to be with him in his final days was what I know he wanted. You looked after me so well too. A huge thank you for all you did for us both."

Mission and Vision

Definition and intention

A mission statement defines an organisation's current purpose, outlining what it does and how it aims to achieve its goals, while a vision statement describes the organisation's desired future state, outlining where it aspires to be in the long term, essentially serving as a guiding north star for the organisation's direction and aspirations; both together provide a clear roadmap for a strategic direction and motivate officers and councillors to work towards achieving its goals.

Proposal for Implementing Mission and Vision Statements for Billingshurst Parish Council

Introduction Billingshurst Parish Council plays a vital role in serving the local community by delivering essential local services, supporting residents, and fostering a sustainable and thriving environment. To ensure long-term strategic direction and operational cohesion, the adoption of clear Mission and Vision statements would provide a unified framework for decision-making, service delivery, and community engagement.

Purpose of Mission and Vision Statements A Mission Statement defines the Council's core purpose, responsibilities, and commitment to the community. It outlines what the Council aims to achieve on a daily basis and serves as a guiding principle for its operations.

A Vision Statement sets out the long-term aspirations of the Council, presenting a picture of the future it seeks to create for Billingshurst. It inspires both the Council and the community by aligning efforts towards shared goals.

Key Benefits

1. Strategic Direction

- A Mission Statement ensures that all council activities align with its core responsibilities, preventing mission drift and maintaining focus.
- o A Vision Statement provides long-term goals, helping to shape policies, initiatives, and budget allocations with a clear trajectory.

2. Enhanced Cohesion and Unity

- o Establishing shared objectives promotes collaboration among councillors, staff, and community stakeholders.

- o Helps attract external funding and support by demonstrating a structured and forward-thinking approach.

Implementation Process

- Conduct a consultation with councillors and staff to define the Council's core values, priorities, and long-term objectives. Trevor Leggo who is CEO of SALC offers a facilitatory service to enable this, free as part of our membership subscription to SALC.
- From that consultation, draft Mission and Vision Statements reflecting the Council's role, aspirations, and community needs.
- Review and refine the statements through public engagement to ensure they resonate with residents.
- Integrate the statements into policy documents, strategic plans, and communication materials.
- Regularly review and update the statements to ensure they remain relevant and effective.

Conclusion The adoption of Mission and Vision Statements would provide Billingshurst Parish Council with a structured foundation for long-term success. By defining its purpose and aspirations, the Council can improve service delivery, enhance community engagement, and ensure cohesive governance. Establishing these statements will be a key step in shaping a prosperous future for Billingshurst and its residents.

I would strongly encourage the council to support this proposal and to arrange the consultation with Trevor Leggo to help us to see this become a reality.
