

# Minutes of the Annual Meeting of Billingshurst Parish Council Wednesday 10 May 2023 7pm at the Billingshurst Centre.

Cllr Paul Berry opened the meeting.

#### 33/23 Election of Chairman.

On the proposal of Cllr Paul Berry, seconded by Cllr Doug Waller, **RESOLVED** that Cllr Ken Peters be elected Chairman of the Council for the forthcoming year. Cllr Ken Peters then signed the Statutory Declaration of Acceptance of Office.

Cllr Ken Peters took the Chair.

On the proposal of Cllr Paul Berry, seconded by Cllr Edna Benger, **RESOLVED** that the above be referred to the Working Practices Committee accordingly.

45/23 To consider writing to local MP in support of letter from Campaign to Protect Rural Henfield (CPRH) to Andrew Griffith MP.

CPRH had written to their MP setting out their comments on a Department of Levelling Up, Housing and Communities Housing Policy Consultation. Parish Council Officers had suggested sending a similar letter to Jeremey Quin MP, as the subject matter was very relevant, and indeed cited Billingshurst. On the proposal of Cllr Doug Waller, seconded by Cllr Steve Thomas, **RESOLVED** that a similar letter be sent to Jeremy Quin MP accordingly. (Officers to see if CPRH had received a reply first and adjust letter accordingly.)

46/23 To consider making a proposal to Horsham Association of Local Councils (HALC) for onward forwarding to NALC (National Association of Local Councils), that Parish Councils who can demonstrate that they have a public question time at all meetings, be excused of their obligation to hold an Annual Parish Meeting of Electors each Spring.

Councillors thought that this was an excellent suggestion, especially in the light of the numerous other ways that residents can engage with the Council throughout the year, via a multitude of mediums. On the proposal of Cllr Ken Peters, seconded by Cllr Phillip Day, **RESOLVED** that the suggestion be forwarded to HALC accordingly.

#### 47/23 Reports from:

a. County Councillor Mrs Amanda Jupp congratulated the new Chairman on his election. She had spoken to West Sussex County Council (WSCC) highways officers about moving forward the parish's wish list of traffic calming measures

and was also wondering if a 20mph speed limit plus gateway features should be promoted early, especially near The Alders. Contractors had returned to the Five Oaks roundabout since it had been resurfaced and resolved the flooding issue. There had been some work done to prune hard back the hedge alongside the alreadynarrow footway leading to Five Oaks, but landowners also had responsibility. She was continuing to press for action to address the permanent puddle opposite Rosier Business Park, on the A272. WSCC had leased 3 jet patchers to increase the number of potholes able to be filled; all repairs did require dry weather to be effective. She thanked Parish Council and Centre staff for their efforts in putting on some excellent Coronation events.

- b. District Cllrs Sam Bateman and John Trollope introduced themselves including a little background. They looked forward to working with the Parish Council and perhaps meeting to see how they could best represent the interests of the Parish at HDC.

The minutes of the Annual Parish Meeting of Electors were NOTED. There were no matters requiring the attention of the Council.

# 53/23 To consider suggested public position statement on relationship with strategic developers.

Councillors were mindful that on occasions, Council had to consider an issue whilst exercising different functions. The Council was a planning consultee, but also a landowner. Members were mindful that whilst they may be against, for example, more large-scale housing in the parish, they may wish to take a pragmatic view that to not engage with the same developer, could mean the parish not achieving the very best in terms of new infrastructure should the said developer acquire planning permission. It was felt the Council needed to clarify its general position in such instances.

On the proposal of Cllr Ken Peters, seconded by Cllr Caroline Beresford Pratt, **RESOLVED** that

Billingshurst Parish Council (BPC) is opposed to large scale developments being constructed within the Parish. However, when developers are exploring options, the Council is ready and willing to work with developers for the benefit of the community as they make their application. Therefore, BPC will support West of Billingshurst in so far as we will work with the developer of West as a landowner for what BPC can gain on behalf of the community, but as a Council remain formally opposed to large scale development in the community. (Wording drafted by Cllr Craig Gale).

# 56/23 Exclusion of Press & Public (Contractual - land).

On the proposal of Cllr Sarah Wilson, seconded by Cllr Roy Margetts, **RESOLVED** that in view of the confidential nature of the business about to be transacted (contractual - land), the press and public be temporarily excluded, and they are instructed to withdraw.

# 77/23 Land West of Billingshurst development: To consider proposed contract with Highwood Group ref. use of council-owned land at Jubilee Fields.

Councillors considered the latest draft contract setting out the possible use of land at Jubilee Fields to accommodate new and upgraded sporting facilities, if the Highwood Group were successful in acquiring planning consent for a strategic housing allocation called *West of Billingshurst*. Members noted that in agreeing this, the Council were not in turn bound to support this or any other housing allocation in the parish.

On the proposal of Cllr Ken Peters, seconded by Cllr Steve Thomas, **RESOLVED** that the contract be agreed accordingly, in addition to points (b) - (e) as set out in the Clerk's report.

[Cllr Phillip Day would liaise with the Clerk on some minor queries and the final contract with *tracked* changes would be circulated again to all Councillors prior to being signed. This decision would be conveyed to the three new District Councillors accordingly via a meeting so that they were aware of the Parish Council's position.]
