# 68/23 To receive presentation from Neil Everest, Chairman Silver Key Developments Ltd on proposals to develop land at former Bromeliad Nursery in Marringdean Road, for a bungalow Custom Self Build (CSB) scheme.

This would make good use of a difficult to develop eyesore site and help Horsham District Council meet an unmet demand for such spaces.
